# STUDENT SAFETY AND SECURITY PARENTS/GUARDIANS AND VISITORS

In the interest of safety and to prevent interruptions to classes, Board policy states that all parents/guardians and visitors must inform the main office of their presence in the school. Parents who pick up their children at dismissal <u>must</u> wait in the lobby or office area (unless access to the school is denied e.g., due to COVID-19 protocols etc.) This policy is in place to ensure the safety of all our students and to avoid confusion and disruption in the classroom. Please note that ALL entrances to the school are always locked. Anyone wishing to enter the school must utilize the "buzzer system" to gain access. All visitors are requested to sign in and may be asked to wear identification badges. If a parent/guardian is dropping something off for their child or a teacher, it may be left at the office. Parents/Guardians must give the office consent for all visitors wishing direct contact with their child, this includes siblings not attending St. Francis School. Following these procedures contributes to the safety and security of the school community.

#### **ATTENDANCE/SAFE ARRIVAL**

Parents and guardians are responsible for their children's safety. St. Francis School has a Safe Arrival Program that monitors the attendance of every student at the start of the school day. When a student will be absent or late, it is the responsibility of the parent/guardian to notify the school of the reason. Therefore, if your child is to be late or absent, please inform the school office before 8:30 a.m. We are required by law to account for any pupil's unexplained failure to arrive at school. The preference is to inform the office through Edsby (this allows both the office and the teacher to be informed). Both Edsby and calling allows you to inform the school at any time to leave details about your child's attendance. Please leave your child's full name and grade.

#### **REQUEST FOR TEMPORARY EXCUSAL**

This process is to be used by a parent/guardian (or student 18 years of age or older) requesting the temporary excusal of a student due to a reason such as a (vacation). It is not to be used for medical reasons – a medical note must be provided for those absences.

#### **LATENESS**

Lateness is considered another form of absence, especially if it is habitual. If your child must arrive late, please call and provide a reason. When students are late, they are to report to the office before going to class. Habitual lateness, particularly unexplained tardiness, will be treated seriously.

#### **EDSBY**

In 2023 St Francis, along with all schools in the Sudbury Catholic District School Board, moved to a parent/guardian communication tool called Edsby. Families can access this digital tool through a website browser or a free app. The browser and server needed to gain access is <a href="https://www.scdsb.edsby.com">www.scdsb.edsby.com</a>

#### COMMUNICATION

Close connections between home and school are essential to establishing a positive school climate. It is our goal to keep families informed of what is happening at St. Francis. A monthly newsletter and calendar will be posted in Edsby each month. Most communication will be posted in Edsby to family members. Please be sure to check often and change your notification settings so that you are advised when new information is posted. Other ways to see what is happening at St. Francis include: Facebook:@stfrancisflames

Individual teachers will advise of their preferred method of communication.

Sometimes informative notes requiring parental authorization for events such as: field trips, mass celebrations, sacrament dates, school activities and volunteering will be sent home. Please sign and return these notes to ensure your child's participation.

#### **LOST & FOUND**

Unclaimed articles, except jewelry and electronics will be placed in the lost and found container located outside the gymnasium. Please have your child check regularly!

#### **HOMEWORK**

Homework provides students with the opportunity to reinforce and extend in-school experiences outside of the regular school day. Parents/Guardians share with teachers the responsibility for the educational success of their child(ren) and should actively participate in the child's learning process. Homework is an ideal opportunity for parents to become actively involved in their child's education. Homework in the form of completing assignments and review of schoolwork is an integral part of education. Homework should not be excessive – please contact your child's teacher if he or she seems to have excessive amounts of homework on a regular basis.

#### Parents/Guardians are encouraged to:

- -sign and return forms or projects as requested by the teacher
- -provide help and monitor completion
- -recognize that the completion of homework activities is integral to school success

#### **ADMINISTRATION OF MEDICATION**

The Sudbury Catholic District School Board has a clear policy regarding the administration of medication to students. Listed are a <u>few</u> guidelines:

- The principal or his/her designate will administer the medication for student use only after written authorization on a SCDSB Form has been obtained from the parent/guardian and/or a physician.
- All medication must be turned over to the main office for proper storage, unless carried by student as per treatment plan e.g., auto injector, puffer, etc.
- o Records are maintained regarding dosage, method of administration, and storage.
- All medication must be submitted in its original prescription container with the child's name on the prescription container.
- Non-prescription medication will <u>not be administered</u> unless accompanied by a doctor's note indicating dosage.

Only send the required dosage of medication to school. Ask your pharmacist for two separate containers of medication if possible. One container for home and one container for school. THE SCHOOL WILL MAKE EVERY REASONABLE EFFORT TO ADMINISTER MEDICATION ON TIME TO YOUR CHILD. HOWEVER, SITUATIONS DO ARISE THAT MAY CONFLICT WITH THE TIMING OF MEDICATION. THE SCHOOL IS NOT RESPONSIBLE FOR MEDICATION TRAVELLING BETWEEN HOME AND SCHOOL. If possible, time the administration of medication when your child is at home.

#### **IMMUNIZATION**

For children attending school, the law in Ontario requires a written immunization record or proof of immunization. Incomplete immunization records can result in suspension from school on order of the Medical Officer of Health. For more detailed information contact Public Heath Sudbury & District @705-522-9200.

#### PREVALENT MEDICAL CONDITIONS

As primary caregivers of their child, parents are expected to be active participants in supporting the management of their child's medical condition while attending school. At minimum parents should: educate their child about the condition, guide their child to reach their full potential for self-management and self-advocacy, duly inform the school of the condition(s) and co-create and maintain the Plan of Care for their child with the principal or designate. Please contact the school directly for the appropriate medical forms.

**Epipen** - the school board has a policy for the administration of an Epipen. Upon registration, children with life-threatening allergies **must have a form completed** by parents/guardians. A waiver shall be

signed allowing the child to use the Epipen when necessary. Students with severe allergic reactions should be wearing a medic alert bracelet or necklace clearly identifying his/her allergy and carry their Epipen with them at all times. \*\*School staff will be made aware of ALL students requiring an Epipen and the emergency procedures associated with its use.\*\*

#### **CONCUSSION**

Concussions can only be diagnosed by a medical doctor or nurse practitioner. Any student with a diagnosed concussion, **shall** have a "return to learning and/or physical activity" plan to assist a student return to learning/play. Please contact the school directly for the appropriate medical forms.

#### PEANUT/NUT-CONTROLLED ENVIRONMENT

We have several students who are highly allergic to peanut/nut products, and this can potentially lead to severe and life-threatening reactions. For the safety of all children, parents are asked to refrain from sending peanut/nut products to school. Please seek approval from your child's classroom teacher prior to sending food or beverages to school. Wow butter is not allowed to be sent to school.

#### **CORN AND OTHER FOOD ALLERGIES**

We have students who are allergic to corn and other food products. It is vital you seek approval from your child's classroom teacher prior to sending food or beverages to school. We ask families to help their child understand that we do not share snacks or lunches with others as this is one of the best ways to keep everyone safe.

#### **LEAVING SCHOOL DURING THE SCHOOL DAY**

To be excused from school, students must present a note or parents need to inform the office through Edsby or a phone call explaining the reasons(s) for being excused. The message must be given in the morning. If a student is being picked up during school hours, parents must report to the office, and the student will be called to the office. Once a student arrives at school, they may only leave school grounds with permission from the office. Students who eat lunch at school are NOT ALLOWED to leave school property. For example: students are not allowed to leave school and walk to the store or a fast-food restaurant to pick up a snack or lunch.

#### PICKING UP AND DROPPING OFF STUDENTS - End of Day

Please make sure to contact the school <u>BEFORE 2:00 p.m.</u> if you are making changes to your child's regular end of day routine (e.g. picking up etc...). If you call after this time, we <u>can not guarantee</u> that the message will be relayed to your child on time. If you are picking up your child early please do it by 2:30 or wait until the end of the day dismissal.

#### **EMERGENCY SCHOOL CLOSING**

On extremely rare occasions, circumstances may lead to an emergency school closing. Please make arrangements with a relative, neighbour or friend so that your child has an alternative place to go if you are not available.

#### **BUS TRANSPORTATION**

Transportation is provided through the Student Services Consortium. Guidelines are available on their website. The Consortium establishes the parameters, including collector points for each bus route. As a rule, please note the following:

- 1. Bus transportation is a privilege, not a right.
- 2. Students eligible for transportation must live in a transportation zone.
- 3. Only authorized students may ride on their approved bus route. Students are not permitted to ride on a different bus. E.g., take a friend's bus home etc.
- 4. To ensure the safety of FDK students, it is required that when they are delivered to the regular drop off point, a responsible adult meets the child.
- 5. Bussed students must have a note or families have called the office if not taking the bus. A note/message must be dated for each day a student does not take the bus.

#### **TRANSPORTATION/BUSING**

Bus drivers are responsible for the safe transport of our children to and from school. Parents are urged to stress the necessity of appropriate behaviours while riding the bus. Please note that should a student's behaviour on the bus become a safety hazard, transportation privileges may be suspended or revoked. Pupils excluded from buses must make their own transportation arrangements. Students and parents are reminded that buses are assigned to individuals and that once a bus is assigned the student must take the bus for the year. Remember riding a bus is a privilege, not a right.

#### **CONSORTIUM INFORMATION**

The Transportation Consortium's website is **www.businfo.ca**. This site will provide information on the status of a bus, announcements, delays and procedures. You may also refer to this site concerning inclement weather announcements. If there are any changes to be made regarding bussing, parents are asked to notify the Transportation Consortium directly at 521-1234 or at www.businfo.ca. **Please review the Bus Regulations & Conduct** located on the consortium website.

# BUS CANCELLATION DUE TO SNOW DAYS, ETC.

Kindly note that parents/guardians are required to call the school even if bus transportation is cancelled due to snow days, etc., as the school remains open. We are required by "Safe Arrivals" protocol to verify the whereabouts of children who fail to arrive at school, regardless if buses are running or not. The best way to do this is through Edsby.

#### **LUNCHROOM EXPECTATIONS**

Students will eat lunch in their classroom and will be supervised by a shared lunchroom supervisor. Students are expected to be responsible in their behaviour as well as clean up after themselves. Repeated disruptive or disrespectful behaviour may result in their removal from the classroom setting and/or reassignment in an alternate classroom.

#### THE PROVINCIAL CODE OF CONDUCT

The Education Act permits the Minister of Education to establish a code of conduct governing the behaviour of all persons in schools. The purposes of the Provincial Code of Conduct are:

- 1.1 to ensure that all members of the school community, especially people in positions of authority, are treated with respect and dignity
- 1.2 to promote responsible citizenship by encouraging appropriate participation in the civic life of the school community
- 1.3 to maintain an environment where conflict and difference can be addressed in a manner characterized by respect and civility
- 1.4 to encourage the use of non-violent means to resolve conflict
- 1.5 to promote the safety of people in schools
- 1.6 to discourage the use of alcohol and illegal drugs; including cannabis, except by a medical cannabis user (as defined in the Education Act, a medical cannabis user is a person who is authorized to possess cannabis for the person's own medical purposes in accordance with applicable federal law) 1.7 to prevent bullying in schools.

## FAIR NOTICE TO STAFF, STUDENTS, PARENTS COMMUNITY THREAT ASSESSMENT PROTOCOL

- **Sudbury Catholic District School Board** is committed to providing a safe learning environment for all individuals students, staff, and community members.
- When a person's behaviour poses a serious threat to their safety or the safety of others, the Community Threat Assessment Protocol may be activated.
- The protocol will guide agency personnel to respond quickly to threatening behaviour and put measures into place to protect others and the individual(s) of concern.
- When the Community Threat Assessment Protocol is activated parents/guardians of a minor child/youth will be notified.
- **Sudbury Catholic District School Board**, police services and community partners, including school boards will work together to assess the threat and implement interventions.
- The Community Protocol Partners will share information, advice and support, and plans will be developed to minimize risk.
- The parents/guardians of a minor child/youth who made the threat have an important role to play in the process of gathering information and establishing a plan for the minor child/youth, which will enable the team to evaluate and minimize risk.
- If a concern for safety still exists, and parents/guardians cannot be reached, or if they choose not to provide consent to share information, the threat assessment at a Stage One will proceed.
- In sharing personal information, each individual's right to privacy will be balanced with the need to ensure the safety of all.

#### **CODE OF CONDUCT - STANDARDS OF BEHAVIOUR**

Respect, Civility, and Responsible Citizenship

All members of the Sudbury Catholic District School Board community must:

- ✓ respect and comply with all applicable federal, provincial, and municipal laws
- ✓ demonstrate honesty and integrity
- ✓ respect differences in people, their ideas, and their opinions
- ✓ treat one another with dignity and respect at all times, and especially when there is
  disagreement
- ✓ respect and treat others fairly, regardless of race, ancestry, place of origin, colour, ethnic origin, citizenship, creed, sex, sexual orientation, gender identity, gender expression, age, marital status, family status or disability
- ✓ respect the rights of others
- √ show proper care and regard for school property and the property of others
- √ take appropriate measure to help those in need
- ✓ seek assistance from a member of the school staff, if necessary, to resolve conflict peacefully
- ✓ respect all members of the school community, especially persons in positions of authority
- ✓ respect the need of others to work in an environment that is conducive to learning and teaching
- ✓ not swear at a teacher or at another person in a position of authority.

#### **SAFETY**

All members of the SCDSB school communities must not:

- engage in bullying behaviours
- > commit sexual assault
- traffic weapons or illegal drugs
- give alcohol or cannabis to a minor
- commit robbery
- be in possession of any weapon, including firearms

- use any object to threaten or intimidate another person
- > cause injury to any person with an object
- be in possession of, or be under the influence of, or provide others with alcohol, <u>cannabis</u> (unless the individual has been authorized to use cannabis for medical purposes), and illegal drugs
- > provide others with alcohol, illegal drugs, or cannabis (unless the individual has been authorized to use <u>cannabis</u> for medical purposes)
- inflict or encourage others to inflict bodily harm on another person
- > engage in hate propaganda and other forms of behaviour motivated by hate or bias
- commit an act of vandalism that causes extensive damage to school property or to property located on the premises of the school.

#### **ROLES AND RESPONSIBILITIES**

#### **Students**

Students are to be treated with respect and dignity. In return, they must demonstrate respect for themselves, for others, and for the responsibilities of citizenship through acceptable behaviour. Respect and responsibility are demonstrated when students:

- ✓ come to school prepared, on time, and ready to learn
- ✓ show respect for themselves, and for others, and for those in positions of authority
- ✓ refrain from bringing anything to school that may compromise the safety of others; and
- ✓ follow the established rules and take responsibility for their own actions.

#### **Parents**

Parents play an important role in the education of their children and can support the efforts of school staff in maintaining a safe, inclusive, accepting, and respectful learning environment for all students. Parents fulfil their role when they:

- ✓ are engaged in their child's schoolwork and progress
- ✓ communicate regularly with the school
- √ help their child be appropriately dressed and prepared for school
- ✓ ensure that their child attends school regularly and on time
- ✓ promptly report to the school their child's absence or late arrival
- ✓ become familiar with the Provincial Code of Conduct, the Board's Code of Conduct, and school's Code of Conduct.
- ✓ encourage and assist their child in following the rules of behaviour; and
- ✓ assist school staff in dealing with disciplinary issues involving their child.

#### **Police**

The police play an essential role in making our schools and communities safer. The police investigate incidents in accordance with the protocol developed with local school boards. These protocols are based on the Provincial Model for a Local Police/School Board Protocol, 2015, developed by the Ministry of Community Safety and Correctional Services and the Ministry of Education.

#### **SUSPENSIONS and EXPULSIONS at the Sudbury Catholic District School Board**

#### **SUSPENSIONS**

Under subsection 306 (1) of the Education Act, a principal shall consider whether to suspend a pupil if he or she believes that the pupil has engaged in any of the following activities while at school, at a school related activity or in other circumstances where engaging in the activity will have an impact on the school climate:

- 1. Uttering a threat to inflict serious bodily harm on another person.
- 2. Possessing alcohol or illegal drugs; or unless the student is a medical cannabis user, cannabis 3. Being under the influence of alcohol; or unless the student is a medical cannabis user, cannabis
- 4. Swearing at a teacher or at another person in a position of authority.
- 5. Committing an act of vandalism that causes extensive damage to school property at the pupil's school or to property located on the premises of the pupil's school.
- 6. Bullying.
- 7. Other: Activity that is an activity for which a principal may suspend a pupil under a board policy

Under Bill C-13, it is illegal to distribute intimate images of a person without their consent, regardless of the age of the person in the picture;

Non-consensual sharing of intimate images: Knowingly publishing, distributing, transmitting, selling, making available, or advertising an intimate image of another person while knowing that the person depicted in the image did not give their consent, or being reckless as to whether the person gave their consent. The term "intimate image" refers to a visual recording such as a photograph, instant message, or video recording of a person in which the person is nude or engaged in explicit sexual activity and which was created in circumstances that gave rise to a reasonable expectation of privacy.

Police must be notified when an occurrence happens.

If a principal decides to suspend a pupil for engaging in an activity described in subsection (1), the principal will suspend the pupil from his or her school and from engaging in all school-related activities.

The minimum duration of a suspension is one school day, and the maximum duration is 20 school days.

In considering how long the suspension should be, a principal will take into account any mitigating factors prescribed by the regulations.

#### SUSPENSION PENDING POSSIBLE EXPULSION

Under subsection 310 (1) of the Education Act, a Principal shall suspend a pupil if he or she believes that the pupil has engaged in any of the following activities while at school, at a school - related activity or in other circumstances where engaging in the activity will have an impact on the school climate: see following list (page 9)

- 1. Possessing a weapon, including possessing a firearm
- 2. Using a weapon to cause or to threaten bodily harm to another person
- 3. Committing physical assault on another person that causes bodily harm requiring treatment by a medical practitioner
- 4. Committing a sexual assault
- 5. Trafficking in weapons or in illegal drugs
- 6. Committing robbery
- 7. Giving alcohol or cannabis to a minor
- 8. Bullying, if,
  - a. the pupil has previously been suspended for engaging in bullying, and
  - b. the pupil's continuing presence in the school creates an unacceptable risk to the safety of another person
- 9. Any activity listed in subsection 306 (1) that is motivated by bias, prejudice or hate based on race, national or ethnic origin, language, colour, religion, sex, age, mental or physical disability, sexual orientation, gender identity, gender expression, or any other similar factor.
- 10. Any other activity that, under a policy of a board, is an activity for which a principal must suspend a pupil and, therefore in accordance with this Part, conduct an investigation to determine

whether to recommend to the Board that the pupil be expelled. A pupil who is suspended under this section is suspended from his or her school and from engaging in all school-related activities.

#### **MITIGATING FACTORS AND OTHER FACTORS**

In considering whether to suspend a pupil or whether to recommend to the Board that a pupil be expelled, a principal will consider any mitigating factors or other factors prescribed by the regulations.

#### Mitigating Factors

Pursuant to the Suspension and Expulsion of Pupils Regulation, the following mitigating factors shall be considered:

- a) the pupil does not have the ability to control his or her behaviour
- b) the pupil does not have the ability to understand the foreseeable consequences of his or her behaviour
- c) the pupil's continuing presence in the school does not create an unacceptable risk to the safety of any person.

#### **Other Factors**

The following other factors shall be taken into account if they would mitigate the seriousness of the activity for which the pupil may be or is being suspended or expelled:

- a) the pupil's history
- b) whether a progressive discipline approach has been used with the pupil
- c) whether the activity for which the pupil may be or is being suspended or expelled was related to any harassment of the pupil because of his or her race, ethnic origin, religion, disability, gender, or sexual orientation or to any other harassment
- d) how the suspension or expulsion would affect the pupil's ongoing education e) the age of the pupil

In the case of a pupil for whom an individual education plan has been developed.

- whether the behaviour was a manifestation of a disability identified in the pupil's individual education plan,
- whether appropriate individualized accommodation has been provided, and
- whether the suspension or expulsion is likely to result in an aggravation or worsening of the pupil's behaviour or conduct.

#### **NOTICE TO PARENT OR GUARDIAN**

Section 300.3 of the Education Act specifies that if a Principal believes that a pupil has been harmed as a result of an activity described in subsection 306 (1) or 310 (1), the principal shall, as soon as reasonably possible, notify:

- a) The parent or guardian of the pupil who the principal believes has been harmed.
- b) The parent or guardian of any pupil of the school who the principal believes has engaged in the activity that resulted in the harm.

When notifying a parent or guardian of a pupil who has engaged in the activity that resulted in harm, the principal shall not disclose the name of or any other identifying or personal information about a pupil who has been harmed as a result of the activity, except in so far as is necessary to comply with his or her obligation to disclose the required information.

When notifying parents of these incidents, the principal shall invite the parent or guardian to have a discussion with the Principal about the supports that will be provided for his or her child.

However, the Principal shall not, without the pupil's consent, notify a parent or guardian of a pupil who is 18 years or older, or who is 16 or 17 years old and has withdrawn from parental control. The principal also shall not notify a parent or guardian of a pupil if in the opinion of the principal doing so would put the pupil at risk of harm from a parent or guardian of the pupil, such that the notification is not in the pupil's best interests. Under subsection 301(5.5) of the Education Act, when principals have decided not to notify the parents that their child was involved in a serious student incident, they must, in accordance with Ontario Regulation 472/07, document the rationale for this decision and notify both the teacher who reported the incident and the appropriate supervisory officer of this decision.

In circumstances where board employees have reason to believe that a student may be in need of protection, board employees must call a children's aid society according to the requirements of the Child, Youth and Family Services Act, 2017.

#### PROGRESSIVE DISCIPLINE AND PROMOTING STUDENT BEHAVIOUR

A positive school climate is a crucial component of promoting positive student behaviour, and St. John School recognizes the distinctive expectations for Catholic students as an integration of body, mind and spirit. In addition, St. John School actively endorses a variety of programs and activities that focus on healthy relationships, inclusive and equitable learning environments, character education and positive peer relations.

Progressive discipline is a whole-school approach that utilizes a continuum of interventions, supports, and consequences to address inappropriate student behaviour and to build upon strategies that promote positive behaviours.

When inappropriate behaviour occurs, disciplinary/corrective measures may include but are not limited to the following: an apology to the victim, reprimand, warning, detention, loss of privileges, reflection (think sheet), contact with parents via tracking sheet/phone call/Edsby message/person-to person meeting, removal from class, referral to counseling as available, restitution, development of a behaviour plan, conflict mediation (school and/or police), volunteer service, peer mentoring, suspension, and expulsion.

#### **BULLYING PREVENTION AND INTERVENTION**

Bullying: A form of <u>repeated</u>, <u>persistent</u>, <u>and aggressive behaviour</u> that is directed at an individual or individuals that is intended to cause (or should be known to cause) fear and distress and/or harm to another person's body, feelings, self -esteem or reputation. Bullying occurs in a context where there is a real or perceived power imbalance. (PPM#144, Ministry of Education) *Bullying-We* can all help to stop it...

St. Francis School has an active school-wide bullying prevention and intervention plan that contains components of the following: definition of bullying, prevention strategies, intervention strategies, reporting and responding requirements, training strategies, communication and outreach strategies, and monitoring and review processes.

#### **VOLUNTEERS**

Volunteers are a welcomed resource in our school and assist in a wide range of activities and services. Please know that the SCDSB requires all volunteers to complete a Criminal Reference Check including Vulnerable Sector Screening; and thereafter, an annual Offence Declaration. The principal retains the authority to accept or decline any volunteer's offer of service. The principal will determine the best "fit"

for volunteers' placements. It remains the sole and unfettered discretion of the Board to deny volunteer opportunities to individuals when an individual may pose risk to student or staff safety.

#### **RELIGIOUS ACCOMMODATION**

St. Francis School is committed to the values of freedom of religion and freedom from discriminatory or harassing behaviours based on religion and will take all reasonable steps to provide religious accommodations within the legal rights afforded to the Catholic school system. Such accommodation will be provided to students and their families. Accommodation is based on request and is subject to the Code's criteria of undue hardship, and the Board's ability to fulfill its duties under Board policy and the Education Act.

#### **ACCESSIBILITY STANDARDS FOR CUSTOMER SERVICE**

In compliance with the Customer Service Standard (Accessibility for Ontarians with Disabilities Act), please advise the school if you require assistance to access the facility or any other type of assistance.

#### **DISPUTE RESOLUTION- HOME/SCHOOL COMMUNICATION**

It is our belief that a close working relationship among the partners in education, the home, the school, and the church is essential to foster and maintain a Christian community. While encouraging each partner to carry out his or her proper role in the school community, it is recognized that differences of opinion and problems may arise from time to time.

- 1. <u>Complaint and Teacher:</u> Handle the problem as soon as possible. If possible, call the school and arrange a personal interview with the teacher to discuss the problem and attempt to resolve the matter at this stage.
- 2. <u>Complaint and Principal:</u> The second contact should be to involve the Principal or Vice Principal directly if the two parties fail to resolve the matter.
- 3. <u>Complaint and Superintendent:</u> The third contact should be the Academic Superintendent responsible for your school.
- 4. <u>Appeal to the Board:</u> A complainant may take the matter to the Board if the problem is not resolved satisfactorily at the Director's level.

#### FIRE EVACUATION/LOCKDOWN

As per Board policy, St. Francis School is required to conduct three fire drills and one lock-down drill prior to Christmas Break and three fire drills and one lock- down drill prior to the summer break. Participation in drills is mandatory, as they are conducted to properly prepare students and staff for a possible emergency.

#### **EVACUATION PROCEDURES**

The signal for an evacuation practice is a continuous, loud ringing. As soon as a student hears it, they must stand, walk in a single file without talking, and leave the building by the closest exit. Staff will direct students, and all students must listen carefully to staff members. Evacuation practices are required by law and are conducted to prepare students and staff for the safe evacuation of all from the school. Evacuation practices occur a minimum of six times each school year.

The school has policies in place in case there is an event that makes it necessary for us to evacuate the school area. The designated spot we will walk to is The Our Lady of Hope Church. If this is necessary, we will communicate with families through our social media (FaceBook Page) and we will have emergency phone call logs that we will use to contact all families. Our immediate concern will be to ensure the safety of the students before we have time to communicate with those outside our school.

#### **LOCKDOWN PROCEDURES**

The Principal will announce to the school community through the P.A. system: "Attention, all students and staff, this is a security alert. We are implementing our school lockdown procedures". Students will be directed to remain in their classroom or nearest classroom with the door locked. Absolutely no one will be permitted to enter or leave the school until the lockdown directive is lifted by the Principal or Greater Sudbury Police.

#### STUDENT DRESS CODE

St. Francis Catholic School dress code is aligned with the Provincial Code of Conduct and the Board's mission/vision and Catholic social teachings. Therefore, students must come to school every day prepared to learn. Clothing and footwear must be appropriate and neat for the school setting and activity.

St. Francis Catholic School respects students' rights to express themselves in the way they dress. All students who attend St. Francis Catholic School are expected to respect the school community by dressing appropriately for a K-6 educational environment. Students must come to school every day prepared to learn.

#### **Minimum requirements:**

Clothing must

- 1. cover the groin, buttocks and nipples with material that is not see-through or transparent;
- 2. include more than underwear as the only layer of clothing;
- 3. include footwear with consideration for health and safety;
- 4. ensure that the student's face is not fully obscured;
- 5. not include wording or graphics that reasonably could be construed as promoting or symbolizing hate or discrimination, drugs, alcohol, tobacco, Cannabis, weapons, illegal activity, profanity, nudity, pornography; or that incites violence or harassment; or threatens health and safety.

**Students who do not adhere to these guidelines will not be allowed to attend class.** Parents will be called if appropriate clothing is not available or the student refuses dress-code appropriate clothing.

#### **USE OF LOCKERS**

Students shall keep a clean and respectable locker. Combination locks only are not permitted for students. Lockers are the property of St. Francis and can be accessed by administration at any time.

#### STUDENT USE OF PERSONAL ELECTRONIC DEVICES (PEDs)

As a general rule, \*NEW in 2024\* All elementary (K-8 students) are to refrain from using cell phones during school time. Cell phones that come to school are to be keep in lockers or the office has a drawer they may be left in. Students who break this rule will follow progressive discipline starting with a reminder.

Personal mobile devices are only to be used during instructional time for educational purposes, as directed by an educator; for health and medical purposes; and/or to support special education needs. Students and their parent/guardian shall sign a Student Responsible Use of Information Technology Agreement prior to the student bringing in any PED, accessing the Internet or any Board owned technology.

Electronic devices will not be used during lunch, recesses (indoor or outdoor), or at entry and dismissal. The school does not assume the responsibility for personal mobile devices brought to school.

#### FILMING AND/OR RECORDING BY STUDENTS/PARENTS/GUARDIANS/VISITORS

The filming and/or recording of meetings (including phone calls), events or any other school related activity is not permitted without the express consent/permission of the principal or principal designate.

#### STUDENT USE OF SMALL APPLIANCES

Only appliances related to the programming needs of the students will be allowed in student spaces e.g., classrooms, gathering space, gymnasium, resource rooms etc. Appliances such as, but not limited to, space heaters, microwave ovens, toasters, ovens, kettles, coffee makers, toaster ovens, fridges, water coolers, hot plates, etc., not required for the delivery of curriculum or medical needs are not permitted for personal use. While the benefits of hot meals, drinks and snacks sounds appealing, the potential dangers far outweigh any benefits.

#### SCENT- REDUCED ENVIRONMENT

St. Francis School is asking for voluntary cooperation towards a scent-reduced environment. Students and visitors are encouraged to avoid or reduce the use of products with fragrance. We recognize the right to personal choice; however, the air space is shared, and chemicals released into the air can trigger health reactions (e.g., headaches, asthma attacks, altered behaviour, etc).

#### **SCHOOL NUTRITION & HEALTHY EATING**

Research shows that good health is a prerequisite for good learning. It is also a vital component of children's growth and development. Roughly 1/3 of a child's daily food intake occurs at school and we ask that families provide their children with daily lunches and snacks that reflect a balance of nutrition according to Canada's Food Guide.

#### **SMOKING/E-CIGARETTES/VAPOURS**

Smoking, e-cigarettes, and vapours are not permitted on school property or at any school related event.

#### FIELD TRIPS & SCHOOL RELATED ACTIVITIES/FUNDRAISING TO HELP PAY FOR TRIPS

The opportunity to participate in a field trip or school related activity will not be withheld because of an inability to pay. Every reasonable attempt will be made to include students; however, the principal reserves the right to deny student participation. Teachers will ensure appropriate schoolwork is available and that supervision is arranged for students who remain at school. All proceeds raised through the sale of products to support a student's filed trip are not the property of the student and/or parent and remain solely the assets of the Sudbury Catholic District School Board.

#### MANAGING ILLNESS AT SCHOOL

Sick children are very uncomfortable at school. If your child is ill, please keep them home to recover. When a child complains of feeling ill every effort will be made to send them home. It is imperative that arrangements are made with a relative, friend or neighbour in the event that parents are not available to care for a sick child.

Use of the **FAMILY INFORMATION FORM** to record the name and telephone number of emergency contacts is extremely important. **Three names other than yourself MUST be provided.** 

If your child reports they are ill, the office will contact the home to make arrangements to have your child picked up. We do not have the resources available to care for children who are sick. If your child is not well enough to participate in the regular routine of the school day, including recess, please keep your child at home. To help reduce the spread of infection in schools, Public Health Sudbury and District requires the following infection control protocol for schools (list is not exclusive, common examples only):

#### **CUSTODY**

Should a custody issue regarding your child come about, it is imperative that a copy of the court order(s) be provided to the school for enclosure in the student's file. Custody is a legal issue. If a court order does not exist, or if the school has not been officially made aware, then by virtue of the Children's Law Reform Act, both parents will be deemed to have equal access.

#### **FAMILY INFORMATION**

Please ensure the information we have on file for your child is accurate and up-to-date. Please contact the school immediately if changes occur (e.g., phone #, address, health concerns, custody etc.

#### CATHOLIC SCHOOL COUNCIL
